Scam Corner - Copycat Websites

Trading Standards are raising awareness amongst consumers about copycat websites.

Complaints have been received by the consumer helpline from individuals who have used a website for applications for their blue badge.

The site requires you to give:-

- Details of your disability
- Proof of ID including home address
- A payment of £49.50

An email is then received acknowledging payment. In some cases nothing more is heard in others the application has been forwarded to the correct authority.

Look for "Gov" in the web address. You can start by searching https://www.gov.uk to be confident that you will find the official government site.

Make sure you read everything thoroughly before committing money. If you have any doubts seek advice.

Joint Development Day - West Bromwich Town Hall 28.04.16

On the 28.04.16 Heads of Service. Senior Police representatives as well as Health Partners and others. all members of both Sandwell's Safeguarding Children's Board and Sandwell Safeguarding Adult's Board were present at a local event (the first of its kind in Sandwell) to look at key Safeguarding themes that impact on both adults with support needs and children in this area!

The identified priority areas were:

- Modern Slavery
- Prevent

 Transition and Vulnerable Young Adults

 Crisis Mental Health Concordation

Professionals and experts in all of the above areas set out the key challenges and provided information to ensure all partners were well informed. There was lots of group work and discussion with active contributions from all statutory partners.

People considered the relationship between both Boards, the Health & Wellbeing Board and the Community Safety Partnership with a focus on the

potential for Service improvement, agreed branding, continued joint working and smarter working.

All delegates felt the event was positive and a real opportunity to share and develop our understanding of the identified areas.

Next Steps:Action plan to be developed identifying lead responsibilities for the relevant Boards and any potential implications for commissioning and Service development.

Scam Corner Pets Sold Online

A report has come via Action Fraud regarding the sale of pets. In particular "pedigree" puppies and kittens advertised on popular auction websites.

Adverts are placed offering a pet for sale, they claim that the animal is currently being held somewhere less accessible or overseas. Upon agreement of the sale the fraudster will ask for advance payment by money transfer (Western Union/MoneyGram) or bank transfer.

The pet is never delivered the fraudster will then ask for further payments e.g. courier charges, transportation fees.

How to protect yourself:-

- Agree a suitable time to meet face to face to agree the purchase and collect the animal. If they do not want to do this – be suspicious.
- A genuine seller is always keen to ensure the animal is going to a caring home. If they show no interest be suspicious
- If you think that the purchase price is too good to be true, it usually is!
 be suspicious.
- Request copies of the animal's papers, inoculation history, pedigree etc. prior to agreeing the sale. If the seller shows any reluctance or comes up with excuses – be suspicious. If the animal exists it could have been illegally bred at a "Puppy Farm". Illegally bred puppies are more likely to suffer ailments and illnesses.
